In FY25, the Genesis Fund closed 35 loans for over \$20 million, increasing the outstanding loan portfolio to nearly \$50 million. Through this lending, more than 1,200 units of housing were created or preserved. In addition, the Genesis Fund's lending reached over 3,500 additional people through support of community facilities such as healthcare clinics, food pantries, and other community service hubs. The Genesis Fund also provided over 3,300 hours of professional guidance to dozens of projects in FY25, helping to create affordable housing and community facilities by sharing professional knowledge to develop these projects.
