In FY26, the Genesis Fund closed 27 loans for over \$10 million, increasing the outstanding loan portfolio to more than \$50 million. Through this lending, 815 units of housing were created or preserved. In addition, the Genesis Fund's lending reached over 7,500 additional people through support of preserved and expanded food pantries, recovery services, and community development. The Genesis Fund also provided over 2,700 hours of professional guidance to dozens of projects in FY26, helping to create affordable housing and community facilities by sharing professional knowledge to develop these projects.
